We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

### **(1) What information do we collect?**

We may collect, store and use the following kinds of personal data:

1. Information about your visits to and use of this website;
2. Information about any transactions carried out between you and us on or in relation to this website

### **(2) Information about website visits**

We may collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. We may use this information in the administration of this website, to improve the website's usability or to help us understand how widely used the website is.

We use cookies on this website. A cookie is a text file sent by a web server to a web browser, and stored by the browser. The text file is then sent back to the server each time the browser requests a page from the server. This enables the web server to identify and track the web browser.

Most browsers allow you to refuse to accept cookies. (For example, in Internet Explorer you can refuse all cookie by clicking "Tools", "Internet Options", "Privacy", and selecting "Block all cookies" using the sliding selector.) You are able to do this at any time.

### **(3) Lawful basis for processing**

We collect and use you information under the following condition contained within Article 6(1) of the GDPR:

- (a) Consent: the individual has given clear consent for you to process their personal data for a specific purpose.

3. In order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk);
4. Except as provided in this privacy policy, we will not provide your information to third parties.

### **(5) Security of your personal data**

We will take reasonable precautions to prevent the loss, misuse or alteration of your personal information. Our website operates over 128 BIT industry standard Secure Socket Layer data encryption meaning that any information that passes between your browser and our UK hosted website is Encrypted.

We may update this privacy policy from time-to-time by posting a new version on our website. You should check this page occasionally to ensure you are happy with any changes.
